Madam/Sir,

In continuation of the trailing email, please find the attached trade-wise and state-wise details of applications/registrations received as on date for CITS Admissions for the session 2025–26. It is hereby informed that approximately **16,997 candidates** have completed the registration for the CITS courses so far, against the **total seats of 17,275**. The last date for submission of applications under CITS for session 2025-26 is **28th May, 2025**.

It is pertinent to highlight that, the number of applications received should be at least twice the total number of available seats per trade to ensure a competitive and meritorious selection process. However, as per the current data, the number of applications received falls short of the total number of seats, even after allowing candidates who are currently appearing in their final examinations.

In light of the above, I am directed to request the RDs/HoDs and Principals/HoOs of NSTIs to take proactive steps in motivating and guiding the eligible trainees to submit their applications for the CITS programme at the earliest. **It is also requested to ensure that the information regarding the**

**grant of permission for eligibility of appearing candidates to apply for CITS for the 2025–26 session has been conveyed to all prospective candidates.**

Further, the RDs/HoDs are also requested to ensure wide and effective dissemination of information regarding CITS admissions across all ITIs under your jurisdiction, so as to enhance awareness about the ongoing CITS Admissions among prospective candidates so that maximum registrations can be achieved. The following suggested actions may be adopted for maximising outreach:

1. Organize awareness sessions, career guidance workshops, Conduct interactive webinars for the trainees/Alumni's of ITIs and NSTIs to highlight the relevance and benefits of CITS training.
2. Display informative banners, posters, and digital signages
3. Leverage official social media platforms and websites of NSTIs and ITIs to circulate admission-related notices, video content, and reminders.
4. Engage local print and electronic media, including regional language outlets, to issue public notices and awareness features.
5. Coordinate with State Directorates to circulate admission details through their respective communication channels.

Furthermore, the RDs/HoDs are also requested to nominate nodal officers from respective RDSDE/NSTI for coordination with ITIs/NSTIs/IToTs/ State Directorate for overseeing outreach activities and ensuring regular follow-ups.
